

FAQ

Do I need a fishing license to fish on MacDill AFB?

Yes, you will need a Florida freshwater license to take freshwater fish and a Florida saltwater license to take saltwater fish. Therefore, a 1) freshwater 2) saltwater or 3) freshwater-saltwater combination license is required to take fish. (To "take" is legally defined as taking, attempting to take, or killing fish). Can I stand or wade in the water to fish?

No, all fishing, as authorized in areas #1 and #3 which are indicated on the map on the reverse side of this guide, must be conducted from the shoreline or designated dock. Wade fishing is prohibited.

Can I fish while kayaking, boating, or paddle boarding?

Fishing from small non-motorized craft is permitted in the MacDill recreation area identified by authorized area #2 on the map. This extends west from the marina channel to the boundary of the coastal restricted area.

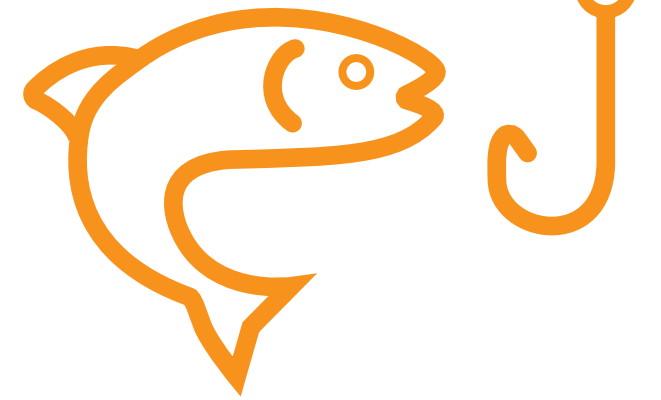

Unauthorized Areas

- ⊘ All Stormwater ponds and lakes located in MacDill residential and industrial areas
- ⊘ All ponds and lakes of Bay Lakes Golf Course
- ⊘ MacDill Coastal Restricted Area

Prohibited Bait

- Black Bass (any part)
- Peacock Bass (any part)
- Live non-native fish
(variable platys & fathead minnows allowed)
- Live goldfish



Regulations

Spearfishing for mullet in fresh water is prohibited; however, gigging from above water is permitted.

- UCMJ Article 92 (Military Members)
- Title 18 U.S.C. 1382 (Trespass) or 18 U.S.C. 13 (Assimilated Florida Law) (Civilians)
